**ORDER**

On January 10, 2012, this Arbitrator issued an Opinion and Award (the "Award") in the above referenced matter. On August 8, 2012, the FLRA upheld the Award. This Arbitrator ordered the Parties to work together to implement the Award as written. The process of implementation has been overseen by this Arbitrator since then, on an ongoing and continuous basis.

In the Summary of Implementation Meeting dated August 2, 2014, upheld by the FLRA on May 22, 2015, this Arbitrator noted that the Award covers all PHRS and CIRS bargaining unit employees employed during the relevant damages period. Pursuant to this Arbitrator's directives, the Union provided its list of PHRS and CIRS class members to the Agency in early 2014. On June 12, 2014, the Agency requested an additional thirty days to provide a response to the Union's list of eligible employees who encumbered PHRS or CIRS positions. This Arbitrator permitted the Agency an additional opportunity to compile such list within thirty days from the date of the June 2, 2014, Implementation Meeting. The Parties were to discuss their respective

PHRS and CIRS lists if they differed. The Agency did not present a list within thirty days of the June 2, 2014, meeting; as such, no discussion was had, as there were no differing lists.

The FLRA has upheld this Arbitrator's Award and subsequent August 2, 2014 Summary. In light of these rulings, the Agency, despite being provided the opportunity to do so, has not contested eligibility of the employees listed on the attached Exhibits<sup>1</sup>.

The Agency is hereby ORDERED to retroactively promote all of the employees listed on the attached Exhibits to the earliest date of eligibility or January 18, 2002 (whichever is later), in accordance with the Award and subsequent Summaries. This process shall be as follows:

1. The Agency shall promote all current GS-12 employees who are contained on the attached Exhibits to the GS-13 level, in compliance with the Award, within thirty days (30) of this ORDER.
2. Within forty-five (45) days of the date of this ORDER, the Agency shall provide the Union with a list of the retroactive date of promotion and estimated back pay with interest, emoluments, for each of the employees listed on the attached Exhibits. For retirees, the Agency shall provide estimated backpay, interest, emoluments and revised annuity calculations.
3. Within thirty (30) days of receipt of the Agency's estimates, the Union shall provide comments to the Agency.
4. Within fourteen (14) days of receipt of the Union's comments, the Agency shall process all undisputed payments.
5. Any remaining disputes shall be submitted to this Arbitrator for resolution.

<sup>1</sup> The Agency has contested these employees' eligibility based upon its own methodology. However, the FLRA has upheld the Award and subsequent Summary and the Agency has not contested that any of the named employees in the attached exhibits should be eligible class members, based on the methodology adopted by the Arbitrator therein.

6. Estimated payments amounts shall be transmitted from the Agency to the Union no less than ten (10) days prior to the amounts being paid. As payments are made, or as soon thereafter is possible, the Agency shall notify the Union of the exact amounts paid, including the breakdown of taxes.
7. Within one (1) week of the date of this ORDER, OPM shall be notified about this ORDER and shall be provided a copy, along with a list of retired employees. The Agency shall request, in writing (with a copy of the request to be provided to this Arbitrator and the Union) that OPM expedite the processing of retirement annuity recalculations. Copies of all correspondence between the Agency and OPM shall be provided in a timely manner to the Union and to this Arbitrator. The intent is that all annuities shall be recalculated by OPM in an expedited manner; if there is a delay in processing, the Agency shall work with OPM in order to expedite the processing.

If it further ORDERED that the Parties are to continue to work together to identify additional PHRS or CIRS employees that may be eligible class members and bring those employees to this Arbitrator's attention for a determination.
